

THE MINUTES OF THE BOARD OF EDUCATION OF  
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10  
March 21, 2022

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on March 21, 2022.

1. Board President Elliott Tuprin called the regular meeting to order at 7:00 p.m. Upon roll call members present were Josh Roberts, Chris Goode, Joe Kinser, Chris Weller, Kate Garner, Brandi Rynders and Elliott Turpin. 2. Roberts motioned and Rynders seconded to approve the agenda as presented. Upon roll call Weller, Rynders, Goode, Kinser, Roberts, Garner and Turpin voted “Aye”. Motion carried.
