

THE MINUTES OF THE BOARD OF EDUCATION OF
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10
October 18, 2021

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session at the Administrative Office on October 18, 2021.

1. Board President Elliott Turpin called the meeting to order at 7:00 p.m. Upon roll call board members physically present were Joe Kinser, Kate Garner and Elliott Turpin. Joining the meeting remotely were Chris Goode and Brandi Rynders. Josh Roberts and Chris Weller were absent. Also present were Elementary Principal Jeremy Lansaw, High School Principal Beth Bettis, Beth Burrow, Ron Plogger, Jacob Bollman, Joe Weisner, Joelle Ford, Rachel Arnold, Allie Burrow, Superintendent Kevin Bowman and Becky McClelland.
2. Kinser motioned and Garner seconded to approve the agenda. Upon roll call Rynders, Goode, Kinser, Garner and Turpin voted “Aye”. Motion carried.
3. Goode motioned and Kinser seconded to approve the budget hearing minutes, regular board meeting minutes and executive session minutes from September 20, 2021. Upon roll call Garner, Goode, Kinser, Rynders and Turpin voted “Aye”. Motion carried.
4. Kinser motioned and Garner seconded to approve the Consent Agenda as presented. Upon roll call Garner, Rynders, Goode, Kinser and Turpin voted “Aye”. Motion carried. (See Exhibit No. 1 attached to the Official Minutes)
5. District Highlights – Mrs. Beth Burrow, District Agriculture teacher
Mrs. Burrow showed two videos that were produced by Bayer spotlighting the FFA farm and the FFA students. Joelle Ford, Rachel Arnold and Allie Burrow were present at the meeting representing the Greenfield FFA. A large number of students were able to attend the Farm Progress Show this year. Students also received several firsts in the Ag Sales and Interview contests.
6. Dr. Bowman reviewed the monthly FRIS financial report.
7. Ron Plogger reported on Transportation/Facilities:
 - Dirt work in progress
 - High School window project nearly complete
 - High School football field light project should be finished by the end of October
 - Boilers have been serviced and are ready for colder weather
 - Re-keying district doors – A quote from Gardener L & M Glass was received to re-key all the district doors. (See Exhibit No. 2 attached to the Official Minutes)
8. Elliott Turpin reported on the Greenfield Foundation for Educational Excellence. The next meeting will be held on Wednesday, October 20, 2021. Fall raffle tickets are available.
9. Dr. Bowman announced that School Board Members Day is November 15, 2021 and Principal Appreciation Day is October 29, 2021.
10. Dr. Bowman reported that the FY2020 IDEA Determination shows that the District meets all requirements. Dr. Bowman thanked the staff, parents and students in achieving this goal.

11. Personnel:

- Approve 3 year notice of retirement for John Bayless
- Hire Elementary Secretary Hilary Hunn

12. A Memo of Understanding was presented to the BOE for consideration in regarding changes to sick leave. This memo would give ten (10) paid covid leave days for certain conditions. (See Exhibit No. 3 attached to the Official Minutes)

13. Dr. Bowman discussed the ESSER III Grant and different options available with this grant.

14. A letter was read from a former student inquiring about a donation to the Hunt Scholarship Loan Program. Turpin said he would be happy to discuss options with the former student.

15. Mrs. Beth Burrow spoke to the BOE regarding the possibility of an International Ag trip for students and staff. Three options are available through EF Tours. Agriculture related trips are available to the Dominican Republic, Ireland or Italy. If BOE approves, she would go ahead and schedule an informational meeting with EF Tours. This projected trip would take place in 2023.

16. Kinser motioned and Garner seconded to approve re-keying the District doors with the Schlage Primus option for \$5,425 plus an additional \$800 for 100 keys. Upon roll call Rynders, Kinser, Garner, Goode and Turpin voted "Aye". Motion carried. (See Exhibit No. 2 attached to the Official Minutes)

17. Goode motioned and Rynders seconded to approve the FY21 Annual Financial Report that was presented at the September board meeting. Upon roll call Rynders, Kinser, Garner, Goode and Turpin voted "Aye". Motion carried.

18. Rynders motioned and Kinser seconded hire Makenzie Coffey as a teacher aide at the Elementary School. Upon roll call Kinser, Garner, Goode, Rynders and Turpin voted "Aye". Motion carried.

19. Kinser motioned and Goode seconded to approve the 3-year notice of retirement for John Bayless as presented. Upon roll call Garner, Goode, Rynders, Kinser and Turpin voted "Aye". Motion carried. (See Exhibit No. 4 attached to the Official Minutes)

20. Kinser motioned and Garner seconded to approve the hire of Hilary Hunn as the Elementary Secretary. Upon roll call Garner, Goode, Rynders, Kinser and Turpin voted "Aye". Motion carried.

21. Goode motioned and Kinser seconded to approve the Memo of Understanding with the Greenfield Education Association as presented. Upon roll call Goode, Rynders, Kinser, Garner and Turpin voted "Aye". Motion carried. (See Exhibit No. 3 attached to the Official Minutes)

22. Kinser motioned and Goode seconded to approve the ESSER III grant as presented. Upon roll call Rynders, Kinser, Garner, Goode and Turpin voted “Aye”. Motion carried.

23. Kinser motioned and Garner seconded to authorize Mrs. Beth Burrow to explore an international agriculture trip for 2023. Upon roll call Rynders, Kinser, Garner, Goode and Turpin voted “Aye”. Motion carried.
