

THE MINUTES OF THE BOARD OF EDUCATION OF
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10
February 15, 2021

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on February 15, 2021.

1. Board President Rodney Knittel called the regular meeting to order at 7:00 p.m. Upon roll call members physically present were Joe Kinser, Chris Weller and Rodney Knittel. Joining remotely were Elliott Turpin, Josh Roberts, Chris Goode, Brandi Rynders and Becky McClelland. Dr. Kevin Bowman was physically present.

2. Turpin motioned and Roberts seconded to approve the agenda as presented. Upon roll call Kinser, Roberts, Turpin, Goode, Weller, Rynders and Knittel voted “Aye”. Motion carried.

3. Kinser motioned and Weller seconded to approve the January 25, 2021 regular minutes as presented. Upon roll call Roberts, Turpin, Goode, Weller, Rynders, Kinser and Knittel voted “Aye”. Motion carried.

12. Weller motioned and Kinser seconded to hire John Davidson as a full-time district bus driver. Upon roll call Rynders, Kinser, Roberts, Turpin, Goode, Weller and Knittel voted “Aye”. Motion carried.
13. Roberts motioned and Weller seconded to authorize the Superintendent to post for a High School English teacher. Upon roll call Kinser, Roberts, Turpin, Goode, Weller and Knittel voted “Aye”. Motion carried.
14. Correspondence – A thank you note was read from the family of Marlene Meneley for the memorial in her honor.
