

THE MINUTES OF THE BOARD OF EDUCATION OF  
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10  
January 22, 2024

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on January 22, 2024.
