THE MINUTES OF THE BOARD OF EDUCATION OF GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10 November 20, 2017

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session in the Administrative Office on November 20, 2017.

- 1. Board of Education members were provided pizza and dessert courtesy of Kevin and Lauren Bowman in appreciation for their service to the school and community. Elementary students performed their literary pieces for the board during the meal. Students performing included Elaina Lansaw, Lucy Rives, Addison Wright and Kate Pearson. Lucy Rives and Addison Wright received the Judge's Choice award which selects the best performances of the all the participants.
- 2. President Rodney Knittel called the regular meeting to order at 7:00 p.m. Upon roll call the following members were present: Josh Roberts, Chris Goode, Joe Kinser, Chris Weller, Elliott Turpin, Brandi Rynders and Rodney Knittel. Also present were Superintendent Kevin Bowman, Beth Bettis, Rhonda Bauer and Becky McClelland.
- 3. Turpin motioned and Rynders seconded to approve the agenda as presented. Upon roll call Weller, Rynders, Goode, Kinser, Roberts, Turpin and Knittel voted "Aye". Motion carried.
- 4. Roberts motioned and Kinser seconded to approve the October 16, 2017 regular minutes as presented. Upon roll call Roberts, Weller, Turpin, Goode, Kinser, Rynders and Knittel voted "Aye". Motion carried.
- 5. Turpin motioned and Weller seconded to approve the Consent Agenda as presented. Upon roll call Turpin, Rynders, Weller, Roberts, Goode, Kinser and Knittel voted "Aye". Motion carried. (See Exhibit No. 1 attached to the Official Minutes)
- 6. Superintendent Bowman reported on Facilities/Transportation:
 - -Bus #6 and Bus #9 have been repaired
 - -District is still short one bus driver
 - -Two district employees have started process to drive a bus
 - -Elementary Gym bleacher end curtains completed
 - -Batting cage mat ordered
 - -Metal work covering old brick completed
 - -Loft flooring installed in new addition
 - -Promethean board for second grade has been received
 - -Elementary gym floor cover mats have arrived
 - -Chris Ornellas will be installing a new sound system in Elementary gym
 - -ROE conducted the annual H/L/S visit and no major violations were found
 - -Prairie State Insurance Cooperative conducted their annual safety visit and no problems found
- 7. Elliott Turpin reported on the Greenfield Foundation for Educational Excellence. The Chili-Cook-off netted a profit of \$1400. Sydney Hopper won the grand prize for the cash raffle.

The raffle profit was \$1250. The Foundation has a balance of \$10,000 with the next meeting occurring on January 17, 2018.

- 8. Superintendent Bowman presented three options for the annual tax levy. Two options would not require a public hearing. The third option is for a balloon levy at 6.99% to capture any new growth in the county. This option will require a Truth-In-Taxation public hearing before the December board meeting. Bowman also explained that the district is under PTELL and the Board can levy for 6.99% but will only receive what is allowed by law. Board members agreed to the 6.99% levy and a public hearing on December 18th at 6:45 p.m.
