- 1. Upon roll call Knittel, Roberts, Turpin, Goode, Weller, Rynders and Kinser voted "Aye". Motion carried.
- 7. Turpin motioned and Weller seconded to nominate Josh Roberts to continue to serve as Board Secretary/Treasurer. Upon roll call Roberts, Turpin, Goode, Weller, Rynders, Kinser and Knittel voted "Aye". Motion carried.
- 8. Roberts motioned and Rynders seconded to keep all Board Meeting dates for 2017 as is. Upon roll call Turpin, Goode, Weller, Rynders, Kinser, Roberts and Knittel voted "Aye". Motion carried.
- 9. Goode motioned and Roberts seconded to go to Executive Session at 7:10 p.m. Upon roll call Goode, Weller, Rynders, Kinser, Roberts, Turpin and Knittel voted "Aye". Motion carried.

Goode motioned and Weller seconded to return to Open Session at 8:40 p.m. Upon roll call Weller, Rynders, Knittel, Roberts, Turpin, Goode and Kinser voted "Aye". Motion carried.
