

THE MINUTES OF THE BOARD OF EDUCATION OF
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10
August 4, 2020

The Board of Education of Greenfield Community Unit School District No. 10 met in special session, in the Administrative Office, on August 4, 2020.

1. Upon roll call the following members were physically present: Joe Kinser, Elliott Turpin and Rodney Knittel. Present remotely were Josh Roberts and Chris Goode. Chris Weller remotely joined at 7:07 p.m. Brandi Rynders was absent. Also present were High School Principal Beth Bettis, Beth Burrow, Julie George, Becky Bishop, Dr. Kevin Bowman and Becky McClelland.
2. Roberts motioned and Kinser seconded to approve the amended agenda. Upon roll call Goode, Kinser, Roberts, Turpin and Knittel voted "Aye". Motion carried.
3. Knittel noted that the Board of Education would vote on the reopening plan during Action Items. He asked if there were any questions and there were none. 11. Kinser motioned and Roberts seconded to authorize the Superintendent to post for a High School English Teacher. Upon roll call Roberts, Turpin, Goode, Weller, Kinser and Knittel voted "Aye". Motion carried.
