

THE MINUTES OF THE BOARD OF EDUCATION OF  
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10  
May 17, 2021

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on May 17, 2021.

1. Board President Elliott Turpin called the regular meeting to order at 7:00 p.m. Upon roll call members physically present were Chris Goode, Joe Kinser, Chris Weller, Brandi Rynders, Rodney Knittel and Elliott Turpin. Josh Roberts was absent. Dr. Kevin Bowman, High School Principal Beth Bettis, Elementary Principal Jeremy Lansaw, Ron Plogger, B. L. Pembroke, Jessa Vetter, Nancy Vetter, Jason Vetter, Allison Mettenburg, Kathleen Mettenburg, Matt Mettenburg, Courtney Meyer, Janice Meyer, Eric Meyer and Becky McClelland were also physically present.
2. Rynders motioned and Goode seconded to approve the amended agenda as presented. Item P. under information items was added. Upon roll call Weller, Rynders, Goode, Kinser, Knittel and Turpin voted “Aye”. Motion carried.
3. Knittel motioned and Weller seconded to approve the April, 2021 regular and executive minutes and the April 29, 2021 special meeting minutes as presented. Upon roll call Weller, Knittel, Goode, Kinser, Rynders and Turpin voted “Aye”. Motion carried.

BOE congratulated the students and parents on this achievement.
6. Ron Plogger reported on Transportation/Facilities:
  - Interviews were held for eleven applicants for the summer worker openings.
  - Dirt work and elementary fence are in progress.
  - Football field lights – planning to start work as soon as possible. Discussion revolved around the restoration of the Fleur de Lis sign and pillars at the entrance to the field.
  - B.L. Pembroke spoke to the BOE about the need for new bleachers at the football field. District Architect Tony Audo informed the BOE of handicapped accessibility issues related to this type of project.
7. Elliott Turpin reported on the Greenfield Foundation for Educational Excellence. Students will receive eighteen (18) scholarships at graduation. The next meeting will be August 19, 2021.
