

THE MINUTES OF THE BOARD OF EDUCATION OF  
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10  
September 19, 2022

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session at the Administrative Office on September 19, 2022.

1. President Elliott Turpin called the Budget Hearing to order at 6:45 p.m. Upon roll call the following members were present: Josh Roberts, Chris Goode, Joe Kinser, Kate Garner, Brandi Rynders and Elliott Turpin. Also present were Interim Superintendent Dr. William Phillips, Rhonda Bauer, Stephanie Vetter and Assistant Superintendent Andy Stumpf. There was no comment from the public. Goode motioned to close the budget hearing and Rynders seconded. Motion carried. Budget Hearing was adjourned at 6:55 p.m.
2. President Elliott Turpin called the regular meeting to order at 7:00 p.m. Upon roll call the following members were present: Josh Roberts, Chris Goode, Joe Kinser, Kate Garner, Brandi Rynders and Elliott Turpin. Chris Weller joined the meeting at 7:07 p.m. Also present were Robyn Klingler, Lauren Nettles, Stephanie Vetter, Rhonda Bauer, High School Principal Beth Bettis, Ron Plogger, Dr. Phillips and Andy Stumpf.
3. Rynders motioned and Roberts seconded to approve the agenda. Upon roll call Rynders, Goode, Kinser, Roberts, Garner and Turpin voted “Aye”. Motion carried.
4. Kinser motioned and Garner seconded to approve the August 15<sup>th</sup> regular board meeting minutes, August 22<sup>nd</sup> and August 29<sup>th</sup> special board meeting minutes and August 15<sup>th</sup>, August 22<sup>nd</sup> and August 29<sup>th</sup> executive session minutes. Upon roll call Roberts, Garner, Goode, Kinser, Rynders and Turpin voted “Aye”. Motion carried.

Copies of the summary pages and full audit were distributed and reviewed. Greenfield CUSD #10 was rated at 3.90 which is Recognition Status.
