

THE MINUTES OF THE BOARD OF EDUCATION OF
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10
October 20, 2020

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on October 20, 2020.

1. Board President Rodney Knittel called the regular meeting to order at 7:00 p.m. Upon roll call Brandi Rynders joined remotely and those physically present were Josh Roberts, Joe Kinser, Elliott Turpin and Rodney Knittel. Chris Goode and Chris Weller were absent. Also physically present were Superintendent Kevin Bowman, High School Principal Beth Bettis, Elementary Principal Jeremy Lansaw, Ron Plogger and Becky McClelland.
2. Roberts motioned and Kinser seconded to approve the agenda as presented. Upon roll call Rynders, Kinser, Roberts, Turpin and Knittel voted "Aye". Motion carried.
3. Roberts motioned and Turpin seconded to approve September 22, 2020 budget hearing minutes and the regular meeting minutes as presented. Upon roll call Roberts, Turpin, Kinser, Rynders and Knittel voted "Aye". Motion carried.
4. Kinser motioned and Roberts seconded to approve the consent agenda as presented. Upon roll call Turpin, Rynders, Roberts, Kinser and Knittel voted "Aye". Motion carried. (See Exhibit No. 1 attached to the Official Minutes)
5. District Highlights – Dr. Bowman presented a video showing the evolution of the High School Locker Room renovation. Prior to the start of the meeting, Dr. Bowman and several BOE members walked through the locker rooms. The High School Auditorium was also briefly visited to view the completed ceiling and should be completed by the end of the week.
6. Dr. Bowman reviewed the monthly FRIS Report.
7. Ron Plogger reported on Transportation/Facilities:
 - Dirt work is in progress at all buildings
 - Elementary fence is in progress
 - Summer 2020 update – Locker room project is complete and HS chairlift is finished. HS roof will begin in November as soon as auditorium is finished.
 - Pre-K shed has been delivered
 - Bus #4 is being repaired by C & K Collision and a rental bus is being used
8. Elliott Turpin reported on the Greenfield Foundation for Educational Excellence. A donation of \$500 was given to the Greene-Calhoun CEO Program. No mini-grant applications have been received yet. Treasurer's balance is \$13,152.34 and the next meeting will be held on October 28, 2020.
9. Dr. Bowman announced that School Board Members Day will be November 15, 2020. A supper will be held prior to the November board meeting. Principal Appreciation Day will be held on October 23, 2020.
10. Dr. Bowman congratulated staff and administration on achieving the meets requirements on the Illinois IDEA Determination Report.

11. Personnel – hire one-on-one teacher aide Brittany Wiser.
