

THE MINUTES OF THE BOARD OF EDUCATION OF
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10
December 20, 2021

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on December 20, 2021.

1. Board President Elliott Turpin called the regular meeting to order at 7:00 p.m. Upon roll call members physical present were Chris Goode, Joe Kinser, Chris Weller, Kate Garner, Brandi Rynders and Elliott Turpin.
