

THE MINUTES OF THE BOARD OF EDUCATION OF  
GREENFIELD COMMUNITY UNIT SCHOOL DISTRICT NO. 10  
June 20, 2022

The Board of Education of Greenfield Community Unit School District No. 10 met in regular session, in the Administrative Office, on June 20, 2022.

1. Board President Elliott Turpin called the tuition waiver hearing to order at 6:30 p.m. Upon roll call members present were Chris Goode, Joe Kinser, Kate Garner, Brandi Rynders and Elliott Turpin. Josh Roberts entered the meeting at 6:34 p.m. Chris Weller was absent. Also present were Dr. Kevin Bowman, Stephanie Vetter and Dr. Phillips. Elliott Turpin reviewed the narrative for Tuition Waiver. There were no public comments or questions.
2. Rynders motioned and Roberts seconded to adjourn the tuition waiver hearing at 6:37 p.m. Upon roll call Rynders, Goode, Kinser, Roberts, Garner and Turpin voted "Aye". Motion carried.

9. District Highlights –Mrs. Bettis reviewed with the BOE and the audience the many achievements and accomplishments that have taken place the past 12 years while Dr. Bowman has been superintendent. Bettis emphasized on all the structural, technology and academic improvements that have taken place.

10. Ron Plogger reported on Facilities/Transportation:

- Dirt work - in progress in all buildings
- HS window and HVAC projects start June 1 start date but the HS windows will not be here until late July
- Football field entrance – no news at this time
- HLS amendment 19 for Elementary HVAC was approved
- District rekeying project will be done this summer
- District office ceiling – Ron has it on his list
- HS stair treads – starting to see an issue. Plan is to replace the ones that have issues on an individual basis.
- Bus #1 still needs broke down & Maws salvage need to get it for scrap

11. Elliott Turpin reported on Greenfield Foundation for Educational Excellence. Eleven scholarships were awarded to graduating seniors. The next meeting will be held on August 10, 2022.

22. Roberts motioned and Kinser seconded to accept the resignation of Sarah Johnson as the Prekindergarten teacher for the 2022-2023 school year. Upon roll call Goode, Weller, Rynders, Kinser, Roberts, Garner and Turpin voted "Aye". Motion carried.
